III. Update on Measure A1 news – Jennifer Pearce, Housing Specialist, Housing and Community Development Manager, Alameda County Community Development Agency (CDA)
Informational Item

Discussion:

Ms. Pearce gave an update on Measure A1 recent news:
 Board of Supervisors

- Housing Preservation Loan Program administrator contract with Habitat for Humanity East Bay/Silicon Valley was extended on August 4, 2020.
- The Measure A1 Citizens' Oversight Committee by-laws will be considered by the Board of Supervisor in late September or early October.
- Board of Supervisors approved commitments of \$2,330,306 from the A1 Rental Base City allocation to Albany Family, in Albany, to support 61 affordable units July 28, 2020.

### **Rental Project Updates:**

- Rosefield Village Alameda 90 affordable units, supported with \$8,093,414 A1 funding Anticipated Loan Closed 8/11/2020
- Fon Lok West/Brooklyn Basin Parcel A1 Oakland 129 affordable units, supported with \$9,698,000 A1 funding—Loan Closed 7/29/2020
- Likely Permanent Finance Conversions in September 2020 for Estrella Vista (3706 San Pablo)
   Casa Arabella (Fruitvale Village-II A)
   Coliseum Connections
   Camino 23
- Ms. Potter informed the Committee of Alameda Point, a 70- unit project that closed in June and is under construction.

# V. Measure A1 Implementation Update – Rental Development - Francisco Gomez, Housing and Community Development Manager (HCD)

Discussion of A1 programs' progress and status.

### Discussion:

- Chairperson Okwelogu introduced Mr. Gomez, Housing and Community Development Manager.
- Mr. Gomez began the Measure A1 Implementation Update Rental Development presentation.
- Ms. Pearce began presenting on preparation for the Measure A1 Bond.
- Mr. Gomez continued the presentation.
- Mr. Dixon requested the updated presentation as the ethnicity report is not included in the slide deck provided to the Committee.
- Mr. Greg wanted to confirm if this presentation will be posted on the HCD website.
- Ms. Pearce confirmed the presentation will be posted.
- Ms. DeHollander requested staff to confirm the Committee will receive a Project Summary, including unit breakdown for each project.
- Mr. Fuller explained some project summaries have been provided to the Committee and others are in progress.
- Ms. Potter questioned how projects labels such as "senior", "veteran", etc. are determined.
- Mr. Gomez explained certain projects target a specific population, but prospective applicants can apply with a voucher. It is up to the developer to make a decision based on subsidies available. Units are never double counted.
- Vice Chair Bruce requested Mr. Gomez to expand on any specific groups of individuals who need more rental assistance.

• Mr. Gomez explained that a majority of Measure A1-supported projects have been able to maintain cash flow by working with residents to find rental assistance. Staff can work with developers to determine demographics and what communities are being impacted by Covid-19.
