## PUBLIC NOTICE Draft Consolidated Annual Performance and Evaluation Report of the Alameda County HOME Consortium

Jurisdictions which are eligible to receive federal funding from housing and community development programs administered by the United States Department of Housing and Urban Development (HUD) are required to prepare a *Consolidated Plan* which outlines needs, strategies, priorities, and programs for the expenditure of federal funds for housing and community development activities. The Consolidated Plan also combines the applications and reporting requirements for the Community Development Block Grant (CDBG), Emergency Solutions Grant (ESG), and HOME Investment Partnerships (HOME) formula programs. The Consolidated Plan is a planning document built on public participation and intergovernmental consultation.

For the purpose of receiving and administering HOME funds, the Alameda County HOME Consortium (Consortium) was formed in 1992 and includes the CDBG-entitlement jurisdictions of Alameda, Fremont, Hayward, Livermore, Pleasanton, San Leandro, Union City, and the Urban County (the jurisdictions of Albany, Dublin, Emeryville, Newark, and Piedmont, and the unincorporated areas of the County). In May 2015, the Consortium adopted a Five-Year Consolidated Plan for Fiscal Years 2015 through 2019.

The Consortium has prepared a *Consolidated Annual Performance and Evaluation Report (CAPER)* to assess performance during Fiscal Year 2018 under the federal programs covered by the Consolidated Plan. This report covers the period July 1, 2018 through June 30, 2019. It includes the Annual Performance Report for the HOME, CDBG and ESG Programs, and the Annual Performance Report by each of the entitlement jurisdictions assessing their performance according to the Consolidated Plan.

The draft CAPER will be available for review beginning September 9, 2019 at the Planning or Community Development offices of the cities of Alameda, Albany, Dublin, Emeryville, Fremont, Hayward, Livermore, Newark, Piedmont, Pleasanton, San Leandro, and Union City, and the office of the Alameda County Housing and Community Development Department. The draft CAPER will also be available at the main libraries in Alameda, Albany, Castro Valley, Dublin, Fremont, Hayward, Livermore, Newark, Pleasanton, San Leandro, San Lorenzo, and Union City. The public review period will end on September 23, 2019.

A public hearing will be held on Tuesday, September 10th at 7:00 p.m. to take comments on the CAPER. The hearing will be held at the office of Alameda County Community Development Agency, 224 W. Winton Avenue, Room 160, in Hayward, California. Meeting room is wheelchair accessible. Sign Language interpreter may be available upon request upon five (5) days notice to (510) 670-5948.
