Member Gosselin made the motion to approve the Consent Calendar per staff recommendations. The Chair seconded the motion, which carried 2/0. Member Flavetta was excused.

REGULAR CALENDAR:

1. **BIOSOLIDS RECYCLING, CONDITIONAL USE PERMIT, C-8311** – Application to allow continued operation of a biosolids composting facility, in an "A" (Agricultural) District, located on Jess Ranch Road, south side, approximately 0.2 miles west of Grantline Road, unincorporated Livermore area of Alameda County, bearing Assessor's Parcel Number: 099B-6400-002-06.

Mr. Gray read the project description adding that the description should read landspreading and not composting. At the last renewal hearing, the Board had approved a one year permit. Staff has recommended a continuance at the request of the Applicant and awaiting Waste Management response. The Chair requested that a copy of the minutes from the prior hearing be attached with the next staff report. The Applicant was not available and no other testimony was submitted. Member Gosselin made the motion to continue the matter to October 28th and the Chair seconded the motion. Motion carried 2/0. Member Flavetta was excused.

2. **ALAN and CATHY CERRO, CONDITIONAL USE PERMIT, C-8314** – Application to allow continued operation of an existing boarding operation for 35 horses, occupancy of an existing caretaker's unit and expansion up to 60 horses, in an "A" (Agricultural) District, located at 4758 Cross Road, north side, approximately 0.444 miles northwest of Reuss Road, unincorporated Livermore area of Alameda County, bearing Assessor's Parcel Number: 099A-2003-001-00.

Mr. Gray noted that the Applicant has requested a continuance as all conditions from the prior approval has not been implemented. Staff was not sure if the property had the same owner or if there was a new owner.

Public testimony was called for. The Applicant was not available. Three neighbors, Jeff and Tina Ashton, and Jeff Gil were available but opted to offer their testimony at the October 28th hearing. Public testimony was closed.

Member Gosselin made the motion to continue the application to October 28, 2004. The Chair seconded the motion, which carried 2/0. Member Flavetta was excused.

Approval of Minutes – July 29, 2004. Member Gosselin made the motion to approve the Minutes as submitted. Chair Harvey seconded the motion, which carried 2/0/1. Member Flavetta was excused.

STAFF COMMENTS & CORRESPONDENCE: At the request of Mr. Gray, the Board confirmed the November 18th and December 9th hearing dates.

Mr. Gray also announced that the Board is invited to attend an event sponsored by Supervisor Steele at the Children's Memorial Grove in San Leandro. The event is for all the children who have passed away.

If EBZA members were interested in attending, he could forward a RSVP on their behalf.

Mr. Gray also discussed his participation in a panel discussion at the Bay Area Chapter of Sierra Club at the Oakland Library last week. The focus of discussion was wind energy and its effects on protected bird species. There were a number of good questions from the audience. He will provide details about the next scheduled meeting of this Sierra Club committee. In response to whether BZA members could attend, Mr. Gray indicated that although he thought there would be no Brown Act issues or concerns, he would double-check with County Counsel.

CHAIR'S REPORT: None.

BOARD ANNOUNCEMENTS, COMMENTS AND REPORTS: Member Gosselin, in reference to the Stakeholders' meeting last month, said he would like to see Mitigation Funding to remain in Alameda County. He would be providing a presentation at the next Agricultural Committee meeting and asked if it would be a Brown Act concern. He also asked which staff planner would be in attendance. Mr. Gray explained that the presentation will eventually be presented to the Working Group and by October 14th, a draft plan of the Management Program will be available. A discussion followed. Mr. Gray said he has been asked to attend the meeting. Member Gosselin indicated that he would forward all related materials/emails to Mr. Gray.

Member Gosselin discussed the Skinner Application on Vasco Road adding that he had spoken to Gary Moore, Grading Department on general grading issues. He requested information on Title 24 and any mitigations and exemptions that may apply. Mr. Gray said he would check into it.
