Commissioner Kirby made the motion to approve the January 20th Minutes as submitted and the Consent Calendar. Commissioner Ready seconded. Motion carried unanimously, 4/0.

1. PROPOSED ZONING ORDINANCE AMENDMENTS RELATING TO AGRICULTURAL CARETAKERS' DWELLING UNITS (ACDUs). Staff Planner: Bruce Jensen

Mr. Jensen read the staff report. No public testimony was submitted. Commissioner Rhodes noted the numbering error on page 3 of the Resolution. On County Counsel's advice, staff will renumber / reletter the resolution and delete the word 'superseded'. Commissioner Kirby noted that there are no changes in what constitutes an agricultural dwelling but allows more consistency with the Building Code and cleans the language. Staff agreed and Ms. McElligott added that although it does not affect the actual use, it affects the types of structures that can be agricultural caretakers' units. A discussion ensued regarding retention of small farmhouses, qualifying secondary units, and temporary agricultural caretakers' units. Commissioner Jacob expressed concerns regarding the location of the caretakers' units--outside the building envelope and in reference to SDR #B <u>2</u> (page 4), last sentence, he recommended that the report provide as much information as possible. Mr. Jensen stated that staff had similar concerns.

Commissioner Kirby made the motion to move staff recommendation with the recommended re-lettering and Commissioner Ready seconded. Motion carried unanimously, 4/0, with Commissioner Carbone excused and Commissioners Imhof and Loisel absent.
