For the additional three parcels inserted above in Table-1C, some areas of the Grass Lands' and County (Transportation Corridor) properties would be traversed by underground energy collection lines, whereas a short segment of improved access road would be built across the extreme southwest corner of the Ralph Properties II site (under 150' in length, though roughly 40' in width). No turbines are proposed on them.

Although all property owners within 500' of the Grass Lands' and added County properties were notified of the hearing, one parcel within 500' of the Ralph Properties II parcel was not provided in accordance with normal County procedures, because of the incomplete information (listed by the Assessor's as Kuhn, Gary L & Dolores E TRS, & Castello, Melvin, et al). However, although one of the property owners, as "Dolores Kuhn, et al" was sent notice of the hearing at an address previously associated with her family as part of the "interested parties" mailing list for the project, Ms. Kuhn reported that she had not received such a notice at her current address. However, based on telephone calls made by Planning staff to Ms. Kuhn and the co-owner of the subject parcel, Melvin Castello, they have acknowledged that they were contacted 24 hours prior to the hearing and that they have no opposition to the proposed project.
