#### **Topic Introduction: Champion**

- o Goals:
  - Common understanding of meaning of energy efficiency
  - educating public; energy efficiency programs throughout county for residents
  - coordination and consistency among regulations;
  - 4-6 ideas for future discussion, collaboration is key
- o Accountability needed with climate action plans, AB32, etc.
- Better buildings co-benefits, smart energy efficiency
  - New buildings change codes
  - Existing buildings 40% reduction
  - Services, financing, rebates, incentives
  - Residential and commercial
- Three objectives:
  - Focus on measures to reduce natural gas (currently 55 75% emissions now) (e.g., space heating, water heating)
  - Building Performance e.g., building analysis, home performance tests, retrofits
  - Consistent standards need to harmonize CEC, HERS, Green Point Rated, local and state

#### Facing Challenges: Regional Agency Rep

- Work with communities to develop Climate Action Plans
- Determining goals and resources

- Energy Watch Partnership Program
  - what are sectors
  - what are community needs
  - can be used as tool for Climate Action Plan development
  - target specific components (industrial, small commercial, residential, etc.) and align resources
  - Plan out for longer time horizon
- Difficult for municipalities to determine best programs to provide efficiency (energy and financial); PG&E, ABAG trying to coordinate

#### January 23, 2016 Headlines

- Bay Area: Silicon Valley of the Green Economy
  - Many green businesses
  - policy change drove market transformation
  - residential/commercial energy ordinances
  - model for green workforce training
  - intellectual capital (universities)
- City of Hayward's Weatherization Program weatherized 3,000 Homes
  - Cost savings resulted; 10% of GHG Reductions
  - Castro Valley Achieves Zero Energy Status
    - Pedestrian friendly city center
    - bike and car share
    - development around BART
    - people take train to work
    - solar panels, wind
- Cities in Alameda County Achieve 100% Energy Efficiency Retrofit of Existing Residences
  - Residential Energy Efficiency Climate Credit (Chicago Climate Exchange) to fund infrastructure
  - assessment districts for ee
  - energy efficiency or check/audit for homes every 5 years (similar to a car smog check) and at point of sale
- Altamont Windmills Power the Whole City of Livermore
- o All 30,000 Homes in Livermore powered by solar
  - SolarCities program, use Safeway model
- Alameda County USA's First Energy and Carbon Neutral Subdivision

#### **Brainstorming – Projects to Review**

#### **Top Ideas:**

- Require energy footprint disclosure for residential sector (to listings on MLS, etc.)
- Water Conservation Programs at all building levels
- Reduce municipal building energy by at least 20% (state goal)

• Countywide comprehensive training and education program for zero energy goals

#### Second Tier:

- 100% compliance with the Title 24 Energy Code (residential & commercial)
- Expansion of Berkeley First program to all Alameda County and Cities (financing solar through property tax) Note: stopwaste.org is working as a JPA to expand program to all of Alameda County
- Tax incentives for businesses that reduce energy by 50%
- Hire folks from green job training programs to accomplish reductions
- Full implementation for AB1103 (Point of lease law) commercial lessor required to turn over energy benchmark; acts as a marketing tool, motivator for poor performing buildings; expand to individual units/leased spaces; work on implementation issues

#### **Other Brainstorming:**

- Get all businesses in business districts doing energy efficiency
- Expand the use of existing city and county rehab loans to include energy efficiency projects in addition to health and safety
- Schools: Build an education component with energy efficiency measures, include school districts
- o National Energy Efficiency Week
- Federal funds directly to cities for energy use (block grants)
- o Identify and address electricity infrastructure and distribution needs
- o Creating uniform business standards for the region
- Program for multi-family homes with incentives for landlords; give them energy efficiency ratings; financing
- o Coordination on State Level Regulations
